The ASB discussed the final decision on the re-evaluation of 2% liquid strychnine concentrate, the registration for 2% liquid strychnine concentrate has been cancelled. The Pest Management Regulatory Agency will be implementing a three-year phase out period. One year of sale by registrant from March 4th, 2020 until March 4th, 2021. One year of sale by retailer from the last date of sale by registrant followed by one year permitted used from the last date of sale by the retailer. The ASB discussed pricing for strychnine in 2020.

The Assistant Agricultural Fieldman present a letter that was received from the Edgerton Agricultural Society's Ladies Sprig Break Committee requesting sponsorship for the 2020 event. The committee requested sponsorship for \$400.00 to cover the cost of the hall rental.

The Pest Control Office has removed three beavers on the Ribstone Creek and removed nine problem coyotes.

The Agricultural Fieldman informed the ASB the dynamite license has been renewed.
