The Construction Foreman shall measure out borrow pits while onsite before the pits are reclaimed.

6.4.17 Fencing Compensation for Road Construction & Road Widening

(a) When Fence Is In Place At Time Of Construction:

The M.D. will pay landowner \$687.50 per 1/2 mile of fence. If the landowner wishes to salvage existing fence, he may do so at his own cost or may request the M.D. to remove it at a cost of \$300 per 1/2 mile to the landowner. An additional \$600 per 1/2 mile will be paid to the landowner if he or his contractor constructs a new fence within one year of road construction completion on the 100' right-of-way only; <u>OR</u> the M.D. will

provide a new fence.

If no fence is in place, or if a fence is on the Municipal Road Allowance, compensation will not be paid.
