Reeve Barss presented Clr. Andersen with an M.D. watch and thanked her for her 6 years of service. He noted that she was the first lady on Council and she represented her division well and also noted that we appreciate everything she has done and brought to the table. Clr. Andersen thanked everyone for their support and requested that Council support the new Division #6 Councillor and continues with the projects she started.

Travis McClung from Caterpillar, Randy Mabbutt, Bret Everett and Paul Bechard from Finning attended Council to address concerns of Council. Council discussed the downtime of the leased 627H CAT scraper and equipment in general. Council advised that the scraper has been down at least 15 days which is costing the M.D. \$1,087.00 per day just on the lease alone not even counting what productively the other scraper is at because of the two scrapers being a pull-push team. The Director of Public Works advised that it has been up to 2 or 3 days before a mechanic gets out to diagnose the machine. Finning advised that they will work on a quicker response. We could assist by providing more information to the mechanic to help diagnose the problem and ordering parts prior to coming out. It was the consensus that the Satellite coverage be flagged and put up as a priority. Also discussed was the diagnostic computer program which cost was \$1,800 and an annual fee of \$1,200. Travis McClung from Caterpillar said they would keep both up and running for the rest of the year and add 6 more months of warranty on both machines and when the machines are shut down for the year they would have them hauled at their cost to Edmonton and complete all updates and improvements. Paul Bechard from Finning summarized by saying they will do the warranty extension, go back to CAT Finance to discuss the downtime, look at purchasing the diagnostic tool and the process of the mechanic being called. Everyone agreed that communication is the key. The Director of Public Works also asked about the cost of the D7 rebuilds. Finning advised that it is a certified rebuild with a new serial number basically considered a new machine at the cost of 60% to 75% of a new machine. They also advised that the M.D. should consider a powertrain plus hydraulics rebuild first. Randy Mabbutt advised that once all the paperwork is in place they will be picking up the final Terex Scraper reference motion #338.13.
