Reeve Barss asked if there were any oral submissions.

Oral comments opposing the amendment to Bylaw No. 1605 were heard from Charlene Porter. Her concerns were the increase in traffic destroying the road, verbal dispute with Konrad Nanias over slowing down and that there is now commercial traffic going through Greenshields. She also stated people of an elite status are getting preferential treatment. Clr. Buck addressed this concern and wanted to make it clear to everyone that equal treatment is received at this Council table. Kevin Bernauer had concerns about the community expanding and minutes limiting this in 1987. Reeve Barss addressed this advising that things change and everything is discussed and decisions are made on the merit of Council, and furthermore that is why we have these public hearings for input and all input will be considered. Ralph Patterson informed Council he was surprised at how many submissions there are against this and noted that they own the balance of the quarter and they will not let any more go to residential but keep it intact as agricultural land. Muriel Patterson advised that 30 years ago if they wanted to subdivide it would be connected to utilities without any problem. Charlene Porter also wondered why there would be discretionary uses under Country Residential. Konrad Nanias advised Council that he has been a resident for 28 years and he has no intention of running a business in Greenshields. He plans on building a single residence for his family. He advised that he has two shops in Wainwright for his businesses Buffalo Electric and Buffalo Ventures. Comments were made on his company logo trucks speeding and his bad attitude when approached. Reeve Barss advised the group that we are not here to debate the personal issues. Andrew Dawe asked what implications are in regards to taxes. Reeve Barss advised that all houses are assessed at market value. It was also noted that there are different options for Nanias as there are acreages south for sale. Ron Depner voiced his concerns in regards to sewer and water connections setting precedence. He stated the

bylaw was written well, so why not just follow it or that if it is the intent to expand the Hamlet, develop an area structure plan. Chelsey McBride commented about a separate road into Greenshields for Ron Depner stated it is a great community and everyone is a part of it and he suggested to move in the most responsible manner. Charlene Porter also commented on the extra crime with extra traffic, where as of now we know each other's vehicles and feel secure. Increased development brings new problems, more crime, population and more activity. Kevin Bernauer wants Council to consider everyone's opinion opposed to just one person's. Kirby Nanias advised that the proposed development is a single residential for one house. Arrangements have been made to bring their own water and sewer. Development Officer Kim Christensen advised that there are rules and regulations for setbacks from the lagoon and for animals. Kirby Nanias said he was opposed to an additional access to the hamlet. Muriel Patterson said that in the past many people in this room have tried to purchase this property. Their position might be different today if they would have owned it. She also noted along with her husband Ralph Patterson that as long as they are alive, the balance of the quarter will not be sold as a residential lot. Reeve Barss asked if there were any other comments, there were none.
