*Payment Terms: Royalty payments will begin in 2019 with a payment of \$234,375.00 based on a total of 62,500 metric tonnes (50,000 cubic yards) of gravel at \$3.75/metric tonne (\$4.69/cubic yard). Annual payments of \$117,187.50 will begin in 2020 based on a total of 31,250 metric tonnes (25,000 cubic yards) of gravel at \$3.75/metric tonne (\$4.69/cubic yard) and continue until 2023 for a total cost of \$703,125.00 over 5 years. <u>CARRIED</u>

A Request for Decision form was submitted by the Director of Road Construction regarding the sale of the M.D. owned Caterpillar RM500-1-07 reclaimer.
