Agreement to M.D. of Wainwright Conditions:

- Only M.D. of Wainwright ratepayers may apply to the program (town and village residents are ineligible to apply)
 - Agricultural tenants may apply with written landowner consent
- Eligible land is limited to private parcels only and must be within M.D. of Wainwright boundaries
- There is a limit of 1,000 trees per applicant per year
- All shelterbelts plantings adjacent to municipal roads shall be set back as outlined in the Shelterbelt Establishment Program Information document.
- All shelterbelts shall be set back from power lines a minimum of:
 - a) 7.5 meters for hedges and
 - b) 15.0 meters for tall trees.

B. CONDITIONS/ELIGIBILITY CONTINUED

- Applicants must pick up their trees within 5 business days of their arrival.
- Trees must be paid for at the time of pickup or they will not be released. The cost of the trees is shared at 50% applicant, 50% M.D.
- Tree delivery is expected in May. Applicants will be advised of the delivery date in advance. Failure to pick up ordered trees will result in an invoice for the cost being dispensed and donation of the trees.
- Applicants must agree to indemnify and save harmless the M.D. of Wainwright its elected officials, officers, employees, servants, agents, and contractors from any and all claims, demands, causes of action, loss or damages that may result from the applicant's participation in this program.

C. PLEASE NOTE

- Applications will be accepted from November 1st until January 31st annually for pickup in May. Submissions received past the deadline are ineligible. All applications are subject to approval and may be refused at the discretion of the M.D. of Wainwright. While every effort is made to supply eligible applicants with the species and number of plants requested, certain species may be unavailable.
- The final cost is subject to change pending total order finalization and quantities secured
- The program runs on a first come, first served basis. Once the cap is reached intake will close
- Planting and maintenance of trees is solely the responsibility of the applicant.
- TreeTime guarantees trees within the year of planting if conditions have been met. Contact the M.D. if there has been a failure and you have reviewed the qualifications on the TreeTime website.

D. TREE ORDER

Recommended tree and shrub spacing for shelterbelts:

- Deciduous Trees - minimum 10ft
- Deciduous Shrubs - minimum 3ft
- Coniferous Trees - minimum 10ft

Tree Quantity Calculation:

- Distance of Planting (m/ft) / Spacing 9m/ft) = Number of Trees Required
